In 2019 the UK Government amended the Climate Change Act 2008 introducing a target of at least a 100% reduction in the net carbon account by 2050. This is referred to as the Net Zero Strategy.

Emissions reduction targets

In order to continue our progress toward achieving Net Zero, we have adopted the following carbon reduction targets.

- Continue our transition to greener vehicles in our fleet and reduction in/more efficient travel planning.
- Upgrade heating systems and office facilities to be more energy efficient.
- Choose energy suppliers investing in renewable energy.
- Continue working towards a paperless office.
- Choose suppliers of goods & services that share our environmental mission.

We project that carbon emissions will decrease over the next five years to **32 tCO₂e by 2026**. This is a reduction of 20%.
